Academic Integrity Statement:

Washington International School in Taichung (WIST) holds academic integrity as a core value. As an innovative and collaborative academic community, we believe in developing lifelong learners with the knowledge, skills, and integrity to succeed academically and professionally. Therefore, the WIST community is expected to demonstrate honesty and ethical behavior in all academic activities, including but not limited to tests, assignments, essays, and projects.

Duties and Responsibilities of the School Community:

- Students are responsible for maintaining academic integrity by doing their own work, citing sources correctly, and not cheating, plagiarizing, or using AI to generate work that is presented as their own.
- Teachers are responsible for educating students about academic integrity, identifying instances of cheating, plagiarism, unauthorized use of AI, and reporting violations to the appropriate authorities.
- Parents/guardians are responsible for supporting their children's academic integrity by encouraging honesty and ethical behavior, discussing the consequences of cheating or plagiarism, and monitoring their children's work for signs of academic dishonesty.
- Administrators are responsible for establishing and enforcing academic integrity policies, providing support and resources to teachers and students, and ensuring that all members of the school community are aware of the importance of academic integrity.
- The entire school community is responsible for fostering a culture of academic integrity in which honesty and ethical behavior are valued and encouraged. This can be accomplished through regular discussions, workshops, and activities that educate students, teachers, and parents/guardians about the importance of and adherence to academic integrity.

Academic Misconduct:

Academic misconduct is any act that compromises the integrity of the academic process and undermines the principles of honesty, trust, and fairness. This includes but is not limited to:

1. **Cheating**: Using unauthorized materials or methods to complete an assignment, exam, or other academic task. This can include copying from others, using hidden notes or electronic devices, or collaborating with others without permission.

- 2. **Plagiarism**: Presenting someone else's work or ideas as one's own, without proper attribution or citation. This can include copying from a book, website, or other source, paraphrasing without proper attribution, or submitting work that has been written by someone else.
- 3. **Fabrication**: Falsifying data, information, or sources in order to support one's own arguments or claims. This can include inventing sources, altering data, or making up information in order to make an assignment or project seem more impressive.
- 4. **Sabotage**: Deliberately interfering with the work of others or undermining the academic process. This can include stealing or destroying others' work, spreading false rumors or information, or disrupting class or group activities.
- 5. Aiding Misconduct: Assisting another individual in committing academic misconduct.
- 6. **Unauthorized Use of AI**: Submitting AI generated work that is presented as being the original work of the student.

At WIST, certain courses may allow the use of AI tools. Therefore, it is essential that we adapt and modernize our educational programs and assessment methods to ensure that students acquire the necessary skills to use AI tools ethically and proficiently, all while adhering to our unwavering commitment to the principles of academic integrity. Just as with any external source, it is crucial that we transparently indicate when a piece of work has been generated using AI software. Proper credit to the software should be provided within the body of the text, and appropriate references should be included in the bibliography.

WIST acknowledges that students and the community will utilize AI Generative tools. Students and the community are expected to use these tools in an ethical and responsible manner, with the primary goal of aiding student learning rather than a shortcut to completing work. WIST does not regard any work produced by AI generative tools to be the students' work. When students use AI tools as study aids, they are required to adhere to the following guidelines below:

- All students' work must be their own work.
- Students may use generative AI tools for:
 - Exploring potential topics of inquiry
 - Initiating searches for information sources
 - Confirming their comprehension of complex texts
 - Checking their writing for grammar and tone
- The source must be cited. https://apastyle.apa.org/blog/how-to-cite-chatgpt
- Al will be treated as a tertiary source, not as a primary or secondary source.
- Any time Al is used to substantiate a summary, to paraphrase, or to quote information, it must be cited.
- More than 50 words in a row without citations will be considered plagiarism.

At WIST, we take academic misconduct seriously and expect all members of our community to act with integrity and honesty in all academic activities. Any instance of academic misconduct may result in consequences, up to and including suspension or expulsion from school.

Any form of academic misconduct, including cheating, plagiarism, and any other forms of aforementioned academic dishonesty is strictly prohibited. Such acts will not be tolerated and may result in serious consequences, including but not limited to the following:

Possible Consequences:

First offense:

- Zero points for the assignment or test
- A warning will be issued to the student
- Parent/guardian will be notified of the incident

Second offense:

- Zero points for the assignment or test
- A meeting will be scheduled with the teacher, student, and parent/guardian
- A disciplinary recommendation will be recommended to the administration

Third offense:

- A failing grade for the course
- A meeting will be scheduled with the teacher, student, parent/guardian, and administration
- Depending on the severity of the incident, suspension or expulsion from school may be considered.

The following acts of academic misconduct will result in a warning

- Not using electronic devices in accordance with the following school regulations:
- WIST Internet & Digital Safety Statement
- Infringement of intellectual property rights
- Academic misconduct that is deemed unintentional

The following acts of academic misconduct will result in a minor demerit

- Not using electronic devices in accordance with school regulations, refusing to listen to repeated corrections.
- Violation of examination rules that are minor.
- Falsely using, forging or altering documents, seals and signatures if the circumstances are minor.

- Using non teacher authorized devices during class time without the permission of the teacher and do not correct themselves after being advised.
- Intentionally engaging in academic misconduct on projects, quizzes or assignments.

The following acts of academic misconduct will result in a major demerit

- Not using electronic devices in accordance with class rules, refusing to listen to repeated correction, and the circumstances are serious.
- Violation of examination rules that are serious.
- Falsely using, forging or altering documents, seals and signatures if the circumstances are minor.
- Using non teacher authorized devices during class time without the permission of the teacher and do not correct themselves after being advised.
- A second offense of intentionally engaging in academic misconduct on projects, quizzes or assignments.

Procedures for reporting academic misconduct

- Teachers will fill out the WIST Academic Misconduct Report Form, provide reference
 materials as evidence of the academic misconduct and inform the student's
 homeroom teacher that the form has been submitted to the WIST Coordinator of
 Academic Affairs for review.
- 2. The teacher will maintain the presumption of innocence and continue to grade the assignment, quiz, exam, or any other relevant assessment, while adhering to the school's procedures for addressing academic misconduct.
- Following the above process, the Coordinator of Academic Affairs will review and submit materials and recommendation of consequences to the head of school for approval. If there are objections to the punishment recommendations during review, they will be submitted to the Student Rewards and Punishment Committee for review.
- 4. The decision on consequences shall be made in writing to all parties involved which must include a record of the facts, reasons and basis of the consequence, and recommendations for student improvement. The processing process and announcement should respect the confidentiality of personal information. For serious punishment, if necessary, the guardian may be asked to cooperate in counseling, matters.

Consequences for academic misconduct are administered according to the following regulations:

- Consequences are divided into Honor Card Point Deductions, Warnings, Minor Offense, and Major Offense. The accumulation of disciplinary measures is as follows:
 - After accumulating 10 demerit points, it results in a Warning.
 - Three warnings are equivalent to one Minor Offense.
 - Three Minor Offenses are equivalent to one Major Offense.

Actions that may result in demerit points, warnings, minor and major demerits:

- 1 demerit point for late submission of assignments.
- Issuance of one warning for missing scheduled assignment checks.
- Failing to adhere to electronic device usage regulations and showing no improvement after verbal correction results in one warning.
- Minor intellectual property rights infringement after being reported results in one warning being recorded.
- Minor violations of examination rules result in a minor offense being recorded.

Any time a demerit point is given, it shall be a minimum of one point and a maximum of two points; any excess points shall not be recorded.

Cancellation of disciplinary action records:

- 1. Students who violate school regulations can obtain an application form from the Student Guidance Division. During the assessment and observation period, applicants must engage in 1 to 2 consultations per week with their homeroom teacher or counselor. The homeroom teacher or counselor is required to document the counseling sessions' details and the student's behavior on the application form, which serves as the basis for disciplinary record cancellation approval.
- Students seeking disciplinary record cancellation must complete campus service work.
 Each 30-minute session of campus service can offset 1 point, and so on. Upon completion, it should be endorsed by a school authority and recorded in the counseling records.
- 3. During the period of record cancellation, students who violate school regulations again will receive a warning or a more severe penalty and will have their record cancellation invalidated.

Calculation Method for record cancellation:

- For those seeking clearance with a warning penalty, 6 points can offset one warning.
- For those seeking clearance with a minor offense penalty, 18 points can offset one minor offense.
- For those seeking clearance with a major offense, 36 points can offset one major offense

Campus service should take place on regular school days without disrupting regular class hours. Students can utilize Saturdays or school-authorized times during winter and summer breaks for campus services.

Appendix 1: Guidelines for Student Collaboration:

- 1. Clearly define the group's goals and individual responsibilities: make sure each group member understands what is expected of them and what their individual tasks are. Clearly defining goals and individual responsibilities can help reduce the risk of misunderstandings and miscommunications.

Appendix 3: Academic misconduct as an opportunity for growth and learning:
